**Sub: Non-applicability of Regulation 27 (2) of SEBI (LODR) Regulations, 2015 relating to Quarterly Compliance Report on Corporate Governance for the quarter ended 30<sup>th</sup> June, 2022.**

We wish to bring to your notice that pursuant to Regulation 15(2) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("the Listing Regulations"), the compliance with the corporate governance provisions as specified in Regulation 17, 17A, 18, 19, 20, 21, 22, 23, 24, 24A, 25, 26, 27 and clauses (b) to (i) and (t) of Sub-Regulation (2) of Regulation 46 and Para C, D and E of Schedule V, shall not apply, in respect of:

(a) The listed entity having paid up equity share capital not exceeding rupees ten crore and net worth not exceeding rupees twenty five crore, as on the last day of the previous financial year.

(b) The listed entity which has listed its specified securities on the SME Exchange;
