Sub : Scrutinizer's Report on the remote e-voting and e-voting at the 24th Annual General Meeting of the Members of Simplex Mills Company Limited held through Video Conferencing (VC)/Other Audio Visual Means (OAVM) on 2nd August, 2022

1. I, Ravi Sharma of M/s. Ravi Sharma & Associates, Company Secretaries, Delhi, appointed by the Board of Directors of Simplex Mills Company Limited ("the Company") as the Scrutinizer for the Remote e-Voting and e-Voting at the 24th Annual General Meeting (AGM) held through Video Conferencing (VC)/Other Audio Visual Means (OAVM) on 2nd August, 2022, pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended and in accordance with Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.
2. As required under Section 101 of the Act, a notice of AGM dated 14th May, 2022 along with explanatory statement under Section 102 of the Act was sent to the Members by permitted means i.e. e-mail to those Members whose email addresses are registered with the Company/ Depositories, in compliance with the General Circular Nos. 14/ 2020, 17/2020, 20/2020, 2/2021, 19/2021 and 02/2022, dated 8th April 2020, 13th April 2020, 5th May 2020, 13th January 2021, 8th December, 2021 and 05th May, 2022 respectively (collectively referred to as "MCA Circulars") and SEBI Circulars dated 12th May, 2020 and 15th January, 2021 and 13th May 2022, for seeking approval of members on the resolutions contained in the aforesaid Notice.
3. The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules made thereunder and the applicable regulations of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, relating to e-voting on the resolutions contained in the aforesaid Notice of the 24th Annual General Meeting (AGM) of the Members of the Company. My responsibility as a Scrutinizer is to scrutinize and ensure that the voting done through remote e-voting and e-voting at the AGM done in a fair and transparent manner and to make a Consolidated Scrutinizer's Report of the votes cast "in favour" or "against" the resolutions, based on the reports generated from the e-voting system of National Securities Depository Limited (NSDL), the agency engaged by the Company to provide e-voting facility.
4. The Company provided the e-voting facility offered by NSDL to cast votes by the members of the Company.
5. The shareholders of the Company holding shares as on the "cut-off" date i.e. Tuesday, 26th July, 2022 were entitled to vote on the resolutions as contained in the Notice of the AGM.

Remote e-voting facility was made available to shareholders of the Company to exercise their voting rights from 9.00 a.m. of Saturday, 30th July, 2022 which ended on 5.00 p.m. of Monday, 1st August, 2022.

The e-voting was unblocked in the presence of two witnesses not in employment of the Company in due time after the closure of the e-voting at the AGM and the report on voting done through electronic voting system was generated and the voting was diligently scrutinized.
